

Fraternity & Sorority Life at San Francisco State University

The fraternity and sorority (Greek Life) community at San Francisco State University, a California State University, is diverse, encompassing national, regional, and local chapters that offer students opportunities to form lifelong bonds through brotherhood and sisterhood. With 31 active chapters and six Greek Councils, Greek Life provides enriching experiences that include giving back through community service, fundraising for important causes, and participating in both social and academic activities. These experiences foster personal growth, leadership and professional development, and create a sense of belonging, allowing students to build meaningful relationships and enhance their overall university experience while positively impacting both campus and the surrounding community.

Student Activities & Events

Student Activities & Events (SAE) at San Francisco State University fosters student engagement through diverse opportunities that promote personal growth, leadership, and community building. With over 280 student organizations, students can explore extracurricular interests ranging from cultural, academic, and professional clubs. The department supports the creation of campus-wide events, leadership programs, and campus traditions, empowering students to develop leadership skills through active involvement and build belonging and community across campus. Additionally, the Student Life Events Center (SLEC) at Annex 1, provides space for large-scale campus activities such as performances, conferences, and celebrations.

Campus-Recognized Sorority & Fraternity Transparency Act: AB 524

The California State Legislature and Governor approved Assembly Bill No. 524 (AB 524; Sections 66310-66312 of the California Education Code) in September 2022. AB 524 requires each institution of higher education to include the institution's requirements for campus recognition of a campus-recognized sorority or fraternity, as defined, a requirement that the sorority or fraternity submit to the institution on or before July 1, each year, specified information concerning the sorority's or fraternity's members and their conduct.

Chapter Management

Recognized and active chapters at San Francisco State University are supported with opportunities to become engaged leaders, positively contributing to their organization and the campus community. Chapter leadership receives continuous guidance, support, and resources, enhancing their growth and activities throughout the year. Workshops and resources provided in collaboration with campus partners ensure the success and sustainability of the Greek Life community.

Education & Safety

All registered organizations and clubs are required to complete the annual Student Leader Orientation (SLO). This provides an overview of university requirements for recognition, establishment of bylaws, understanding campus policies for events, and organizational operations. Student Activities & Events supports chapters with event planning, leadership development, conflict management, and navigating Time, Place, and Manner (TPM) policies for both on- and off-campus success. The Student Activities & Events Office collaborates with the following departments: Risk Management, Conference & Events Services, and University Police to ensure student safety for university sanctioned events.

Title IX

Recognized fraternity and sorority chapters must comply with Title IX regulations, promoting a safe, non-discriminatory environment for all members. Chapters receive annual training and additional trainings upon request or in coordination with university or CSU system-wide mandates, on preventing and addressing sexual misconduct, harassment, and gender-based violence to ensure that fraternity and sorority life remains supportive and inclusive. Annual training occurs at the Greek Summit each Fall semester in collaboration with the Office of Equity Programs & Compliance.

Hazing Prevention

Hazing prevention is a core focus of Greek Life. All chapters are educated on anti-hazing policies and the dangers associated with such behaviors. Through workshops, training, and university oversight, students are informed of the legal and ethical consequences of hazing, ensuring that all new member processes foster a positive and safe environment.

Student Organization/Club Conduct Procedures

All registered student organizations at San Francisco State University are required to adhere to the University's Recognized Student Organization Code of Conduct (RSOCC). This code ensures that all recognized fraternity and sorority chapters operate within university policies, maintaining the safety, health, and well-being of the community. Organizations are expected to uphold responsible behaviors, with violations potentially resulting in disciplinary action, including probation, suspension, or the loss of University recognition. Regular oversight and sanctions ensure accountability and compliance with university and legal standards.
